

## KBIG-FM's Future Big Stars

### Rules and Regulations

Please read all rules and regulations before submitting your application. Entrants must observe all applicable rules and regulations, or be removed from the competition. Pacific Media Group reserve the right to remove from the talent competition, any entrant not complying with the stated rules and regulations, or any entrant refusing to follow the instructions of security or talent competition officials. Submission of entry form and meeting requirements does not ensure acceptance into the competition.

1. Employees and immediate family members of the Pacific Media Group and its co-sponsors are ineligible to compete in the contest.
2. A contestant may only submit one application and can only appear in one act.
3. Must be a resident of the Big Island.
4. There are two divisions within the talent competition: High School Division and Intermediate/Elementary Division. The division is determined by the grade level for the 2017-2018 school year. All entries not guaranteed a slot. Pacific Media Group will be limiting the amount of entries and will select the 16 acts for the Big Island Fair competition and 16 acts for the Hawaii County Fair competition based on consideration for a variety in the total program. Entries will be notified on August 28, 2017 if they are selected.
5. To be considered, entrants must submit a 30 second video highlighting their talent. Any entries over 30 seconds will be disqualified.
6. The following selection criteria will be considered:
  - A. Appropriateness for fair audiences.
  - B. Capability of production at this particular talent contest facility.
  - C. Originality, creativity, and overall talent.

D. Appearance.

7. Deadline to enter is August 26, 2017.
8. Upon selection, there will be a \$25 dollar entry fee to be collected by September 4, 2017. This entry fee will be used for the prizes, trophies and to secure travel for the 1st place winners to the Brown Bags to Stardom State Finals in 2018. Failure to submit the entry fee by September 4, 2017 will result in the removal of act from the competition and a back up will be selected.
9. Acts will be judged on:
  - A. Quality of performance (including selection)
  - B. Stage presence
  - C. Entertainment value
10. Act not to exceed 3 minutes in length. Any act exceeding the 3 minutes will be disqualified.
11. Vocalists may use taped accompaniment provided tape contains musical accompaniment only. ABSOLUTELY no back up vocals are allowed. A CD or mp3 is REQUIRED and must be submitted a week before the competition. *NO iPods, iPads or cell phones are allowed for accompaniment recordings.*
12. Child/Youth contestants will each receive one admission ticket to fair for the performance day scheduled for each member of the act/group and will receive one additional ticket for a parent/chaperone to accompany them into the fairgrounds the day of participation.
13. KBIG-FM's Future Big Stars will be recorded and aired on the Brown Bags to Stardom tv show. All acts give Pacific Media Group and Brown Bags to Stardom the right to use the recorded performances in any way necessary to promote the contest in future years

with no additional residuals or payment. Pacific Media Group holds the right to use contestant's name and/or photo for any further publicity purposes.

14. Pacific Media Group reserves the right of final decision on any matters pertaining to the Talent Contest not specifically covered by the rules.

15. Pacific Media Group is not responsible for theft/damage or injury of any kind, to persons or instruments, props, clothing etc., during, before or after the performance.

16. The following prizes will be given:

A. 1st Place- Trophy and \$100 Cash. Will represent the Big Island at the Brown Bags to Stardom State Finals in April 2018 including airfare and hotel for the winner.

B. 2nd Place- Trophy and \$50 cash

C. 3rd Place- Trophy and \$25 cash

17. The decision of the Judges is final and scores will not be released to the acts or the public.

18. Pacific Media group has the right to cancel the competition at any time. Contestant will be reimbursed the entry fee if it has already been collected from contestant.
